The Globethics.net online platform offers all users a treasure trove of resources on ethics and related fields for free, including full-text documents from all over the world in different languages, a daily online newsfeed on ethics in five languages selected from 100,000 sources as well as news of events, jobs, calls for papers and new initiatives.

Registered participants have access to even more with the possibility of connecting with others in the online community of over 130,000 participants as well as the use of a wide range of reference and commercial material, including the Oxford handbooks and a wide choice of journals without charge.

We invite you to explore the website, to search the libraries, to see what is happening with others who, like you, are interested in ethics and in being part of a community that shares, reflects and takes action.

Globethics.net Online Libraries

The Globethics.net online libraries aim to increase free availability of quality ethics resources especially in the global South, which often faces barriers to taking part in the global dialogue on ethics because of a lack of access to knowledge resources.

The online libraries are unique in offering access to documents from different sources using one search box: material from commercial publishers, documents harvested from open access repositories worldwide, journals and documents from partner institutions, and documents uploaded directly by Globethics.net participants.

In 2014, new features were developed to make the Globethics.net online libraries even more user friendly: all documents now have a unique link, making them easy to bookmark or to reference. Social media buttons allow easy sharing of documents.

Hundreds of thousands of articles are now available in the libraries without registration, however commercially published journals are available only to registered Globethics.net participants. Altogether, the libraries offer free access to 1,497,964 million documents (at the end of 2014) on ethics and related areas, including documents, articles, books and case

studies in ethics, accessible globally via a multi-lingual portal. This is an increase of 57,964 documents compared to 2013 (not including the documents of the African Law Library).

In 2014, 50 new journals were added to the libraries. Together the libraries offer access to 420 journals and 36 specialised collections, with 59,394 articles downloaded in 2014, and an increasing number of reference works, amounting to a total of 499.

In addition, the libraries offer specialised thematic and institutional online collections.

GlobeEthicsLib

The Global Digital Library on Ethics (GlobeEthicsLib) was launched in 2008, and is now the leading global online library on ethics. The priority of GlobeEthicsLib is to provide full text access to core content in applied ethics to people of the global South and to give the global South an opportunity to make their own research more visible on a global level. The ethics library serves professional practitioners, academics and all others who are actively engaged or interested in applied ethical issues in different sectors of society. In 2014, new special collections included the Green Cross International and the Humanistic Management Center collections.

GlobeTheoLib

The Global Digital Library on Theology and Ecumenism, GlobeTheoLib (www.globethics.net/gtl), launched in 2011, offers direct access to resources on theology, ecumenism and religious studies. In 2014, GlobeTheoLib launched a global research project with other partners on Ecotheology, Climate Justice and Food Security in Theological Education (<http://bit.ly/ecotheology>). The Globethics.net workgroups were used for the production of the Orthodox Handbook on Ecumenism: Resources for Theological Education launched in early 2014.

African Law Library

The African Law Library, which specialises in legislation and court decisions of African countries, was prepared in 2012 and 2013 and launched at the end of 2013. The owner and founder is the African Innovation Foundation (AIF) and Globethics.net was the implementing partner. Following the successful implementation of the first phase in 2014, operational responsibility was then transferred on 1 July 2014 to the project owner, AIF. The African Law Library uses the same platform technology as Globethics.net and remains accessible under www.africanlawlibrary.net

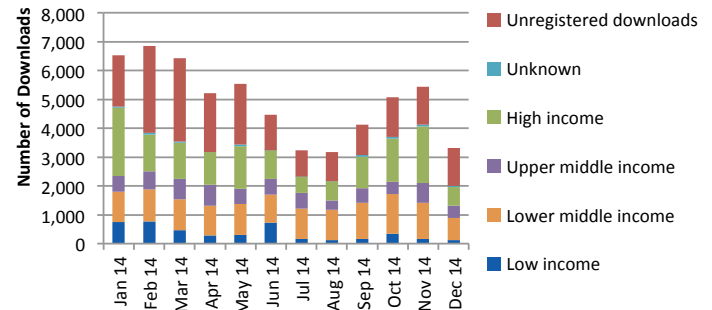

Globethics.net has the biggest online library on ethics in the world. At the end of December 2014, the Globethics.net libraries included

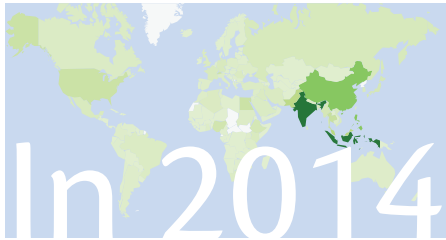
- | 1,497,964 full text documents

On average, about 5,000 documents were downloaded from the libraries each month, in total 59,394 in 2014.

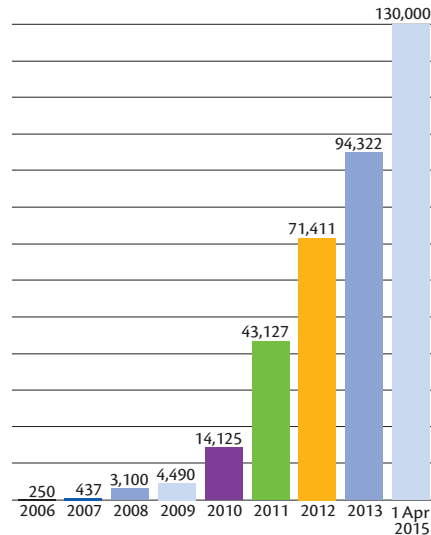

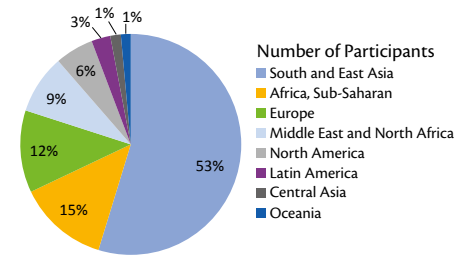

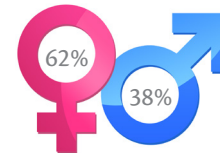

Globethics.net Regional Programmes

Globethics.net is extending its global network through nine regional programmes operating in China, India, Indonesia, East Africa, Francophone Africa, Russia and South America with Southern Africa and Turkey joining early in 2015. The regional programmes work to identify and include ethics resources from their regions in the global libraries, attract new participants, translate website content and documents and engage in regional research programmes and projects. They also cooperate together on occasional inter-regional projects on specific topics.

Each regional programme has a group of two to three directors who hold senior academic or other professional posts and a part-time programme executive. Each regional programme host institution is

different, as is the knowledge and expertise of the directors and staff, bringing a rich diversity to the Globethics.net community.

Globethics.net China

Globethics.net China is hosted and coordinated by the Centre for International Business Ethics (CIBE). Based at the University of International Business and Economics, Beijing, CIBE is an international non-profit research institution. In 2014 the team in China continued adding Chinese content to the library, including through the organisation of an annual essay competition for students on aspects of corporate social responsibility. It contributed substantially to the Global Ethics Forum 2014 that took place in Bangalore, India and to a China-Africa dialogue also conducted in 2014.

Globethics.net Indonesia

Globethics.net Indonesia is hosted and coordinated by the Indonesian Consortium for Religious Studies (ICRS) in Yogyakarta. ICRS-Yogya is a consortium of three universities that together offer an international PhD programme in interreligious studies co-sponsored by Muslim, Christian, and national secular universities. The second largest group of registered participants of Globethics.net is from Indonesia, with over 17,000 persons. The Indonesian office continues to integrate a substantial amount of Indonesian documents and journal articles into the library.

Globethics.net India

Globethics.net India is hosted and coordinated by Dharmaram Vidya Kshetram



College in Bangalore. The team of directors represents various fields of ethics and Indian society: philosophical Indian ethics, business ethics and community and development ethics. India has the largest number of registered participants with over 18,000. The India office worked hard in the run up to the Global Ethics Forum 2014 that took place in early January in Bangalore/India. The team developed a high profile online collection on Hindu ethics and published the Tamil version of the Globethics.net book 'Corruption Free Churches are Possible'.

Globethics.net East Africa

The Kenya based regional programme for East Africa is hosted by the Catholic University of East Africa (CUEA). Its Advisory

Board was established in 2011 and meets regularly to make Globethics.net known in the five countries of the region, Kenya, Tanzania, Uganda, Burundi and Rwanda. Activities in 2014 included a workshop on 'Key Issues in Global Ethics' in Uganda, the second interdisciplinary session in Kenya, a workshop in Burundi on 'Responsible Citizenship as Foundation of Peace' and a seminar in Tanzania on climate change mitigation and adaptation.

Globethics.net Francophone Africa

The regional programme in Francophone Africa is hosted by Dynamique OSCAF, a network of non-governmental organisations in almost 20 francophone countries in Africa with its head office in Cotonou/Benin. In 2014 projects in the region focused

on a collection of proverbs as a booklet and training on "ethics and youth".

Globethics.net Russia

The regional programme in Russia started its activities in September 2013. It is hosted by the Institute for Economic Strategies in Moscow, a scientific and consulting organisation with 300 employees functioning under the auspices of the Social Sciences Division of the Russian Academy of Sciences. Activities in 2014 included an essay competition on responsible leadership, a partnership with the Institute for Philosophy and Ethics in Moscow and cooperation on business ethics with the Association of Orthodox Entrepreneurs in Russia.

Globethics.net South America

The Globethics.net regional programme in South America was launched in April 2014 and the agreement with the host institution, the Latin American Faculty of Social Sciences (FLACSO) based in Buenos Aires/Argentina, was signed in August 2014. FLACSO was founded in 1957 on the initiative of UNESCO as an international, intergovernmental, regional and autonomous body committed to Latin America and the Caribbean. FLACSO has 16 member countries in Latin America and the Caribbean and its activities are dedicated to research, teaching and spreading of social sciences.

Globethics.net Southern Africa

The Southern Africa programme was launched early in 2015 together with the University of South Africa UNISA, the largest open distance learning institution in Africa and the oldest dedicated distance education university in the world. UNISA currently has over 420,000 students enrolled in its courses, nearly one third of all South African students. Cooperation will be on the online documents for the library and e-courses. The cooperation with the Business Ethics Network Ben Africa, based in South Africa, was renewed.

Globethics.net Turkey

Globethics.net Turkey was also launched in 2015, hosted by the Ethics and Reputation Society TEID, founded in May 2010 as a non-profit organisation that aims to develop and encourage adherence to universally recognised business ethics principles and to disseminate them in the Turkish business environment.

National Contacts

The network of Globethics.net National Contacts has been developed alongside the Regional Programmes since November 2012 when the Globethics.net Board of Foundation made the decision to introduce National Contacts as a way to respond to demands and offers from individuals and organisations for services in their countries. There are currently over 30 National Contacts in four continents. Activities carried out included the conclusion of a survey in Africa on the presence of Chinese businesses on the continent facilitated by the National Contact in Belgium. The Globethics.net publications programme continues to grow with a total of 60 titles (by March 2015) in eight series: Global, Focus, Theses, Praxis, Texts, African Law, China Christian and China Ethics. These 60 books have been downloaded 307,082 times in 2014, an average of 25,000 per month.

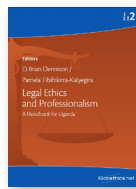
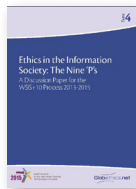
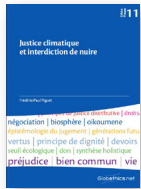

New: Globethics Leadership Centre GLC

In April 2014, Globethics.net opened its new Globethics Leadership Center (GLC). It is a competence centre for services in the field of training for leaders in three sectors: business leaders (with a focus on Small and Medium Enterprises SMEs), religious leaders (with a focus on Church leaders) and political leaders (with a focus on elections).

The main partner of the centre is the Kingdom Business College (KBC) in China which offers trainings for Chinese entrepreneurs in China and Switzerland. The second partner is SEEDS, Social Entrepreneurship and Enterprise Development Services.

The Leadership Centre runs five programmes:

VEC Values-based Enterprise Certificate Business Leadership (China). In 2014, the training tools for entrepreneurs of SMEs in China were developed and the training of trainers was implemented in China. Thirty Chinese entrepreneurs also came for a Globethics.net training to Rome, Berlin and Geneva. Nine other projects related to China have been started.

SME Values-based Sustainability Trainings

SME Leadership (global). In 2014, six modules for an SME training were finalised and a test training was implemented in Bangalore/India. Training sessions were prepared for Zug/Switzerland and Accra/Ghana.

SEEDS Youth Empowerment

Entrepreneurial Leadership (Benin). In 2014, a cooperative was established in Benin and Switzerland to support young social entrepreneurs in Benin/West Africa to start their small businesses.

FIER Election Integrity Trainings

Political Leadership (DR Congo). Globethics.net was mandated by the Federation of Protestant Churches in DR Congo (Eglise du Christ au Congo ECC) to carry out a programme to support training in mediation for fair elections in DR Congo (programme FIER: "Formations intégrité des élections responsables" en RD Congo).

GEF Global Ethics Forum & Workgroups

Multistakeholder Leadership (global): In 2014 the Global Ethics Forum with over 200 participants from all continents concentrated on the topic “Equal in an Unequal World”. Equality of gender, of social and economic classes, in the media, etc., led to the “Globethics Principles on Equality”. For the first time, a prize was given to 10 individuals for their courageous engagement for equality.



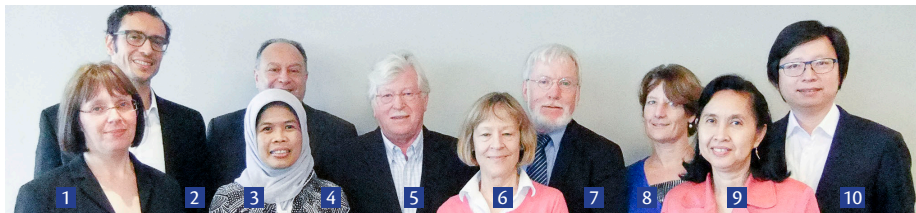
