How should leaders lead? There is probably no domain of public life in which leadership does not play a decisive role in modelling cooperation, participatory action, innovation and co-creation. It is against the background of this conceptual thought that participants will be invited to study the proposed material on leadership agency, accountability and shared creation. A central part of the course is dedicated to the understanding of leadership in alignment with the living of values in democratic societies and in the management of differences, complemented by cross-cultural aspects of leadership and the study of literature and arts.

Structures, bodies, policies, professional relationships, and organisational culture overall constitute salient dimensions for leveraging a propitious ethical climate within a higher education institution.

This course targets primarily administrative officers, human resources and academic office managers, as well as staff responsible for planning, monitoring, evaluating and reporting processes in universities and other higher education institutions. The course provides participants with knowledge, competence, and skills on the relevance of ethics in the context of the execution of administrative tasks, providing leadership and mentorship and interacting with stakeholders across a higher education institution.

Learning contents include, among other things, the study of non-ethical behaviours in relation to student selection and admission, procurement processes, information and data collection and human resources management. Cybersecurity, intercultural differences, privacy protection, copyright and intellectual property protection are included in the discussion questions.

Course participants will be guided to develop critical discernment capacities related to conditions, situations, attitudes, and behaviours leading to conflict and those conducive to building just and peaceful communities. As practiced in different cultures and religious traditions, active listening becomes, in this context, a tool that participants will be equipped with throughout the course.

To obtain the certificate participants need to attend a minimum of 3 live sessions distributed over the three days. Course work related to the clinics can also be accomplished outside of the proposed schedule, provided that all work is completed submitted on the third day.

The World Class participants will be offered time to elaborate a self-guided study on a topic of their choice in relation to themes studied in the 9 live programme units, similar to a short Capstone Project. The course instructor will provide appropriate guidance and supervision. The objective is to conduct the self-guided project throughout the three course days with a completion on the third day. The World Class on Economic, Social and Ecological Ethics focuses on the acquisition of knowledge, competences and skills in the area of sustainable development. The United Nations' Sustainable Development Goals are used as the underlying rationale to analyse the connection between sustainable patterns of production and consumption, care for the environment, wealth distribution, responsible governance and societal participation.

Upon completion of the World Class, you will be able to understand the concept of sustainability as an ethical lens for the study of contemporary challenges; evaluate how economic, social and ecological dimensions inform the international agenda of sustainable development; classify economic, social and ecological measures within a framework of a sustainable transition process, and create a concept for a sustainable transition applicable to your own professional context.

The World Class on Economic, Social and Ecological Ethics was developed and is currently taught by Dr Haluk Haksal, an experienced economist, specialised in sustainability management and sustainable finance.




